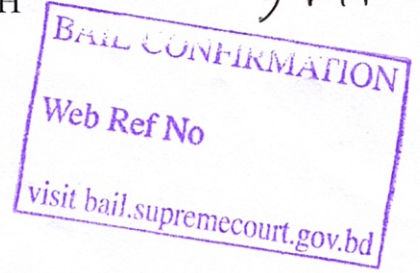

Let the record be called for and Rule be issued calling upon the opposite party to show cause as to why the impugned judgment and order dated 7.03.2016 passed by the learned Additional Sessions Judge, 4th Court, Mymensingh, in Criminal Appeal No.80 of 2004, dismissed the appeal and thereby affirming the judgment and order of conviction and sentence dated 14.09.2004, passed by the learned Additional District Magistrate, Mymensingh, in Haluaghat Police Station Case No.14(11)1998 corresponding to G.R. No.521(2)98, convicting the accused-petitioner under section 326 of the Penal Code and sentencing him to suffer rigorous imprisonment for a period of 1(one) year 6(six) months, should not be set aside and/or to pass such other or further order or orders as to this court may seem fit and proper.

The rule is made returnable within 4(four) weeks from date.

Considering the facts and circumstances of the case and short sentence for a period of 1(one) year 6(six) months out of which he has already served about $3\frac{1}{2}$ months, I'm inclined to enlarge him on bail.

Pending hearing of the Rule, let the accused-petitioner **Danial Mrong @ Daniel Drong** be enlarged on ad-interim bail for a period of 6(six) months in the above mentioned case, to the satisfaction of the learned Chief Judicial Magistrate, Mymensingh.
