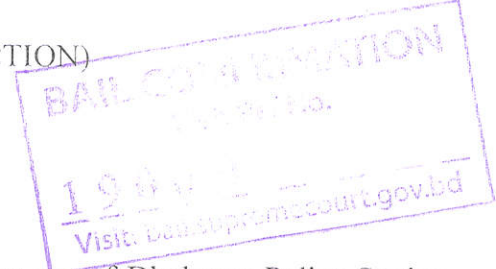

Order

This is an application under Section 498 of the Code of Criminal Procedure for enlarging the accused-petitioner on anticipatory bail in R Case No. 127 of 2018 arising out of Dhobaura Police Station Case No. 13 dated 24.12.2018 under sections 3/4/5/6 of the Explosive Substances Act, 1908 read with section 143/448/323/436/380/34 of the Penal Code,1860 now pending in the court of learned Chief Judicial Magistrate, Mymensingh.

The accused petitioners, who have been identified by their engaged lawyer, surrendered before this Court.

We have perused the application and heard the learned Advocate for the accused petitioners and the learned Deputy Attorney General representing the State who opposed the prayer for anticipatory bail.

Having considered the submissions of the learned Advocate and materials on record, we are inclined to enlarge the accused petitioners on anticipatory bail for a limited period.

Let the accused petitioner Nos. 1.Monjurul Haque @ Monju 2.Sujon 3.Rafique Miah 4. Abu Siddique 5. Rafiqul 6. Jewel Khan 7. Abbas Ali 8. Sharif Uddin son of Saheb Ali and 9. Arif be enlarged on anticipatory bail in the above mentioned case for a period of 04(four) weeks from date, on furnishing bail bond subject to the satisfaction of the learned Sessions Judge, Mymensingh.

Before the expiry of the period of bail, the Court concerned is at liberty to deal with the bail application, if any, of the accused petitioners on merit.

Accordingly, the application is disposed of.
