This is an application for stay of the operation of the order dated 11.03.2020 passed by the learned District judge, Dhaka in Arbitration Miscellaneous case no. 124 of 2020 directing the present petitioner to maintain status-quo from withholding payment of reference rental price (RRP) of monthly invoice of the petitioner and/or deducting any amount from running monthly bills of the petitioner till next date.

I have heard the learned Senior Counsel, Mr. Habibul Islam Bhuiyan and Mr. Ariful Islam, learned counsel and that of Mr. Md. Jahangir Alam, Deputy Attorney-General for the government who very emphatically argues for staying the operation of the said or else the petitioner will highly be prejudiced.


