No. 10 of 2024 under sections 143/447/186/332/333/307/427 and 354 of the Penal Code, now pending in the Court of Chief Judicial Magistrate, Cox's Bazar and/or passed such other or further order or orders as to this Court may seem fit and proper.</p>

		<p>Pending disposal of the Rule, let the accused-petitioners 01. Md. Sadek, son of Md. Abdul Karim 02. Md. Joynal @ Joynal Abedin, son of late Abul Kashem and 03. Md. Shahidullah @ Shahidul Islam, son of Md. Abdul Karim be enlarged on ad-interim bail for 01 (one) year from date on furnishing bail bond subject to the satisfaction of the learned Chief Judicial Magistrate, Cox's Bazar.</p> <p>The Rule is made returnable within 04 (four) weeks from date.</p> <p>The petitioner shall put in 2(two) sets of requisites within 7 days, for service of notice of the Rule upon the opposite party in normal course as well as by registered post with A/D as per the provisions of the Supreme Court of Bangladesh (High Court Division) Rules, 1973. The office shall not issue any certified copy or other copy of this order to the petitioner unless requisites are put in as per the provisions of above Rules.</p> <p>The court below is at liberty to cancel the bail of the petitioner in accordance with law, if the privilege of bail is misused by them in any manner.</p> <p>The accused-petitioners are also directed to file affidavit of facts stating the latest position of the case if further extension of bail is needed.</p>
