An application was filed by the appellant for stay of the operation of the impugned judgment and decree, Mr. A. K. M. Fazlul Hoque, the learned counsel for the appellants-petitioners however submits that it will suffice if an order of status-quo in passed instead of an order of stay. The learned counsel contends that, since the respondents are threatening to dispossess the present appellants-petitioners from the suit land soon after passing the impugned judgment so an order of status-quo may kindly be passed.

I have considered the submission of the learned counsel for the appellant-petitioners, perused the application for stay and that of the impugned judgment. I find substance in the submission so placed by the learned counsel. Accordingly, the alternative prayer made by the learned counsel for passing an order of status-quo is allowed.

Let the parties to the appeal is hereby directed to maintain status-quo in respect of possession and position of the suit properties till 7(seven) days following re-opening of regular bench.

The learned counsel for the appellant-petitioners is hereby directed to place the matter before the competent regular Bench within 7(seven) days on re-opening of regular bench for passing further order.
