	<u>21.04.2025</u>	<p>The delay of 81 days in filing the revisional application is hereby condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite parties to show cause as to why the judgment and order dated 24.11.2024 passed by the Additional Metropolitan Sessions Judge, Court No.7, Chattogram in Criminal Appeal No. 504 of 2023 affirming the judgment and order of conviction and sentence dated 05.03.2023 passed by Chief Metropolitan Magistrate, Chattogram in G.R No. 269 of 2013 arising out of Pahartali</p>	

Police Station Case No. 19(4)2013 convicted the petitioner under section 19(1) table 9(Ka) of the Madok Drobbo Niantran Ain, 1990, sentencing him to suffer rigorous imprisonment for 01(one) year and pay fine of Tk. 1,000/-(one thousand), in default, to suffer simple imprisonment for 10(ten) days more should not be set-aside and/or pass such other or further order or orders as to this court may seem fit and proper.

The Rule is made returnable within 4(four) weeks from date.

Let the realization of fine be stayed.

Let the convict-petitioner, **Md. Zahid @ Dyle Zahid son of Md. Mofzol Ali** be enlarged on bail to the satisfaction of the Chief Metropolitan Magistrate, Chattogram for 06(six) months from date.

The office is directed to serve the notice upon the opposite party by usual course as well as registered post with acknowledgment receipt.

The convict petitioner is directed to put in the requisites forthwith.
