Golam Mostofa Tara who appeared on behalf of the State.  Records be called for.  Let a Rule issued calling upon the opposite-party to show case as to why the judgment and order dated 04.01.2024 passed by Additional Sessions Judge, First Court, Jhenaidah in Criminal Appeal No. 351 of 2019 affirming the judgment and order dated 31.10.2019 passed by the learned Chief Judicial Magistrate, Jhenaidah in G.R. Case No. 309 of 2016, Jhenaidah	

Police Station Case No. 22 dated 21.09.2016 convicting the petitioner under table 19(1) appended to section 9(Ka) of the মাদক দ্রব্য নিয়ন্ত্রণ আইন, ১৯৯০ and sentencing him to suffer rigorous imprisonment for 1(one) year 6 (six) months should not be set aside and/or pass such other or further order or orders as to this Court may seem fit and proper.

The Rule is made returnable within 4(four) weeks from date.

Let the convict-petitioner, **Md. Monirul Islam Kalu Sheikh son of Md. Abdul Barik Mistri** be enlarged on bail to the satisfaction of the Additional Sessions Judge, First Court, Jhenaidah for 06(six) months from date.

The office is directed to serve the notice upon the opposite parties by usual course as well as registered post with acknowledgment receipt.

The convict petitioner is directed to put in the requisites forthwith.
