Session Judge, Court No.4, Narayangonj in Criminal Appeal No. 481 of 2022 affirming the judgment and order of conviction and sentence dated 13.11.2022 passed by the Senior Judicial Magistrate, Narayangonj in Fatullha Police Station Case No. 30 dated 10.08.2021 corresponding G.R No. 528 of 2021 arising out of T.R. Case No. 497 of 2021 convicting the petitioner under section 36(1) table 19 (Ka) of the Madok Drobbo Niyantron Ain, 2018 and sentenced him thereunder to suffer rigorous imprisonment for 6(six) months and to pay a fine of Tk. 2000, in default, to suffer imprisonment for 15(fifteen) days should not be set aside and/or pass such other or further order or orders as to this Court may seem fit and proper.
