	<u>14.01.2025</u>	<p>The delay of 458 days in filing the revision is hereby condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite party to show cause as to why the judgment and order dated 13.08.2023 passed by Additional Session Judge, Court No. 2, Sirajganj in Criminal Appeal No. 136 of 2022 affirming the judgment and order of conviction and sentence dated 30.11.2021 passed by Joint Session Judge, Shahzadpur, Sirajganj in Session Case No. 988 of 2020 arising out of</p>	

C.R. Case No. 228 of 2019 (Shah) convicting the petitioner under section 138 of the Negotiable Instrument Act, 1881 and sentencing him to suffer simple imprisonment for 6 (six) months and also to pay a fine of Tk. 2,50,000/- (two lach and fifty thousand) should not be set aside and/or pass such other or further order or orders as to this court may seem fit and proper.

The Rule is made returnable within 4(four) weeks from date.

The learned Advocate Mr. Md. Shariful Islam appearing on behalf of the convict petitioner submits that the convict petitioner shall pay the remaining 50% of the cheque amount within 06 months and the complainant opposite party No. 2 may be allowed to withdraw the 50% of the cheque amount deposited by the convict petitioner before filing the appeal.

Considering the submission of the learned Advocate for the convict petitioner, I am inclined to enlarge the petitioner on bail for 06 months.

Let the convict-petitioner, **Most. Julekha Khatun wife of Md. Hafizul Ali** be enlarged on bail for a period of 06(six) months from the date on furnishing bail bond to the satisfaction of the Joint Sessions Judge, Shahzadpur, Sirajganj.

The realization of fine be stayed.

The convict petitioner is directed to file an affidavit-in-compliance, if the order granting bail is required to be extended.
