	<b><u>14.05.2025</u></b>	<p>The delay of 374 days in filing the revisional application is hereby condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite parties to show cause as to why the judgment and order of conviction and sentence dated 29.02.2024 passed by learned Additional Sessions Judge, Court No.2, Lakshmsipur in Criminal Appeal No. 35 of 2018 affirming the judgment and order of conviction and sentence dated 04.01.2018 passed by Senior Judicial Magistrate, Court No. 03, Lakshmipur in G.R. No. 155 of 2015</p>	

	<p>(Sadar Lakshmipur) corresponding Lakshmipur Police Station Case No. 58 dated 30.03.2015 under section 19(1) Table 9(Ka)/25 of the Madak Drabbya Niyantaran Ain, 1990 convicting the petitioners in the presence of petitioner No.1 and in the absence of petitioner No. 2 under section 19(1) Table 9(Ka) of the Madak Drabbya Niyantaran Ain, 1990 and sentencing convict petitioner No. 1 to suffer simple imprisonment for 6 (six) months and fine of Tk. 1000.00, in default, to suffer simple imprisonment for a further period of 15(fifteen) days and sentencing the convict-petitioner No. 2 to suffer simple imprisonment for 1(one) year and 6(six) months and fine of Tk. 1000.00, in default, to suffer simple imprisonment for a further period of 1(one) month with direction to run his sentence from his date of surrender or date of arrest in connection with the case and directed to deduct their period of detention in jail as under trial prisoners from the sentence awarded to them should not be set-aside and/or pass such other or further order or orders as to this court may seem fit and proper.</p> <p>The Rule is made returnable within 4(four) weeks from date.</p> <p>Let the realization of fine be stayed.</p> <p>Let the convict-petitioners, 1. <b>Md. Shamsuddin</b> be enlarged on bail to the satisfaction of the Senior Judicial Magistrate, Court No. 3, Lakshmipur for 06(six) months from date.</p> <p>The office is directed to serve the notice upon the opposite party by usual course as well as registered post with acknowledgment receipt.</p> <p>The convict petitioners are directed to put in the requisites forthwith.</p>
