	<u>13.05.2025</u>	<p>The delay of 472 days in filing the revisional application is hereby condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite parties to show cause as to why judgment and order dated 19.11.2023 passed by the Additional Sessions Judge, Court No.1, Netrokona in Criminal Appeal No.156 of 2023 dismissing the appeal and directed to send him on probation for a period of 1 to 3 years and staying the judgment and order dated 16.02.2023 passed by the Senior Judicial Magistrate, Court No.03,</p>	

		<p>Netrokona in TR Case No. 237 of 2020 corresponding GR Case No. 254(2)2019 arising out of Kalmakanda Police Station Case No.22(10)2019 convicted the petitioner under Table 36(1) of section 19(Ka) of Narcotics Control Act, 2018 sentencing him to suffer rigorous imprisonment for 06 (six) months and to pay a fine of Tk. 2,000/- (two thousand) in default, to suffer simple imprisonment for 15(ten) days should not be set-aside and/or pass such other or further order or orders as to this court may seem fit and proper.</p> <p>The Rule is made returnable within 4(four) weeks from date.</p> <p>Let the realization of fine be stayed.</p> <p>Let the convict-petitioner, Md. Rafiqul Islam alias Rafique Khandakar alias Rafique son of Javed Ali alias Shefat Khandakar be enlarged on bail to the satisfaction of the Additional Sessions Judge, Court No. 1, Netrokona for 06(six) months from date.</p> <p>The office is directed to serve the notice upon the opposite party by usual course as well as registered post with acknowledgment receipt.</p> <p>The convict petitioner is directed to put in the requisites forthwith.</p>
