Records be called for.</p> <p>Let a Rule be issued calling upon the opposite party to show cause as to why the impugned judgment and order of conviction and sentence dated 05.03.2024 passed by the Additional District and Sessions Judge, Court No. 3, Naogaon in Criminal Appeal No. 98 of 2019 allowing the criminal appeal in part and thereby setting aside the judgment and order of conviction and sentence dated 12.05.2019 passed by the Senior Judicial Magistrate, Court No. 02, Naogaon in Manda Police Station Case No. 04 dated 30.03.2008 corresponding to G.R. No. 60 of 2008 convicting the appellant-petitioner under Section 323 of the Penal Code, 1860 and sentencing him to suffer rigorous imprisonment for a period of 01(one) year and to pay a fine of Tk. 1,000(one thousand), in default, to suffer simple imprisonment for 30(thirty) days more should not be set aside and/or such other or further order or orders passed as to this Court may</p>
