Akteruzzaman who appeared on behalf of the State.</p> <p>The delay of 172 days in filing criminal revision is condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite party to show cause as to why against the judgment and order dated 18.09.2024 passed by the Additional Sessions Judge, Dewliya Bishoyak Adalot, Dhaka in Criminal Appeal No. 171 of 2024 dismissing the Appeal and thereby affirmed the judgment and order of conviction dated 25.01.2024 passed by the Senior Judicial Magistrate, Dhaka in Complain Registrar (C.R.) Case No. 816 of 2019 (Savar), convicting the petitioner under Section 420 of the Penal Code, 1860 and sentencing him to suffer rigorous imprisonment for 06(six) months and pay a fine of Tk. 5,000 (five thousand), in default, to suffer simple imprisonment for 20(twenty) days should not be set aside and/or such other or further order or orders passed as to this Court may seem fit</p>	

		<p>and proper.</p> <p>The Rule is made returnable within 4(four) weeks from date.</p> <p>Let the realization of fine be stayed.</p> <p>The convict-petitioner having filed supplementary affidavit sworn on 14.05.2025 by Md. Robiul Islam, son of Md. Abdul Khalek undertakes that the convict-petitioner will pay the entire money amounting to Tk. 1,87,000 to the complainant and he prayed for bail of the convict-petitioner.</p> <p>Considering the statement made in the supplementary affidavit dated 14.05.2025, I am inclined to enlarge the convict-petitioner on bail.</p> <p>Let the convict-petitioner Md. Abdul Khaleque, son of late Ibrahim Tarofdar be enlarged on bail for 4(four) months from the date on furnishing bail bond to the satisfaction of the Additional Sessions Judge, Dewliya Bishoyak Adalot, Dhaka.</p> <p>The convict-petitioner is directed to file an affidavit with compliance if before expiry of the date.</p>
