Anichur Rahman Khan who appeared on behalf of the State.</p> <p>The delay of 393 days in filing criminal revision is condoned.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite party to show cause as to why the judgment and order of conviction and sentence passed on 21.03.2024 Additional Sessions Judge, Court No.2, Lakshmipur in Criminal Appeal No. 229 of 2017 affirming the judgment and order of conviction and sentence passed on 10.10.2017 by Additional Chief Judicial Magistrate. Lakshmipur in G.R. No. 63 of 2009 (Ramgati) arising out of Ramgati Police Station Case No. 17 dated 28.06.2009 under Section 447/ 427/ 323/ 448/ 379/ 380/ 385/ 506/ 436/34 of the Penal Code convicting the petitioner in his presence under Section 436/323 of the Penal Code and another under Section 436 of the Penal Code and sentencing him under</p>	

		<p>Section 436 of the Penal Code to suffer rigorous imprisonment for 3(three) years and to pay a fine of Tk. 10,000.00, in default, to suffer simple imprisonment for a further period of 6(six) months and sentencing him under Section 323 of the Penal Code to suffer simple imprisonment for 2(two) months and to pay a fine of Tk. 1000.00, in default, to suffer simple imprisonment for a further period of 10(ten)days with direction to deduct his period of detention in Jail as under trial prisoner from the sentence awarded to him should not be set aside and/or such other or further order or orders passed as to this Court may seem fit and proper.</p> <p>The Rule is made returnable within 4(four) weeks from date.</p> <p>Let the realization of fine be stayed.</p> <p>Let the convict-petitioner Abdus Salam, son of late Abdur Rashid be enlarged on bail for 6(six) months from the date on furnishing bail bond to the satisfaction of the Additional Sessions Judge, Court No.2, Lakshmipur.</p>
