Atiqul Haque who appeared on behalf of the convict-petitioner and the learned Assistant Attorney General Ms. Sharmin Hamid who appeared on behalf of the State.</p> <p>Records be called for.</p> <p>Let a Rule be issued calling upon the opposite party to show cause as to why the impugned judgment and order dated 05.01.2025 passed by the Senior Sessions Judge, Rajshahi in Criminal Appeal No. 567 of 2024 dismissing the appeal summarily on the ground of delay of 243 days in filing the appeal against the judgment and order dated 02.04.2024 passed by the Senior Judicial Magistrate, Rajshahi in Bagmara Police Station Case No. 09 dated 10.03.2021 corresponding to G.R. No. 69 of 2021 convicting the petitioner under Table 21 of Section 36(1) of the Madok Drobbo Niyontron Ain, 2018 and sentencing him to suffer rigorous imprisonment for 06 months and to pay a fine of Tk. 2000 in default to suffer simple imprisonment for 15 days more should not be set aside and/or such other or further order or orders passed as to this Court may seem fit and proper.</p> <p>The Rule is made returnable within 4(four) weeks from date.</p> <p>Let the realization of fine be stayed.</p> <p>Let the convict-petitioner <b>Md. Mohosin Ali, son of late Ahmed</b></p>	

		<p><b>Ali</b> be enlarged on bail for 6(six) months from the date on furnishing bail bond to the satisfaction of the Senior Sessions Judge, Rajshahi.</p>
