No. 197 of 2023</b> arising out of <b>Rajbari Sadar Police Station Case No. 53 dated 25.04.2023</b> under sections <b>302/326/307/34</b> of the Penal Code read with section 3/6 of the <b>Explosive Substances Act, 1908</b>, now pending in the Court of <b>Chief Judicial Magistrate, Rajbari</b> and/or passed such other or further order or orders as to this Court may seem fit and proper.</p>

		<p>Pending disposal of the Rule, let the accused-petitioner <b>Md. Saiful pramanik, son of Md. Jalal Pramanik</b> be enlarged on ad-interim bail for 01 (one) year from date on furnishing bail bond subject to the satisfaction of the learned <b>Chief Judicial Magistrate Rajbari</b>.</p> <p>The Rule is made returnable within 04 (four) weeks from date.</p> <p>The petitioner shall put in 2(two) sets of requisites within 7 days, for service of notice of the Rule upon the opposite party in normal course as well as by registered post with A/D as per the provisions of the Supreme Court of Bangladesh (High Court Division) Rules, 1973.
