Pending disposal of the Rule, let the accused-petitioner Md. Manik Hossain, son of Md. Shahidul Islam be enlarged on adinterim bail for 01 (one) year from date on furnishing bail bond subject to the satisfaction of the learned Additional Sessions Judge, 5th Court, Dinajpur.

The Rule is made returnable within 04 (four) weeks from date.

The petitioner shall put in 2(two) sets of requisites within 7 days, for service of notice of the Rule upon the opposite party in normal course as well as by registered post with A/D as per the provisions of the Supreme Court of Bangladesh (High Court Division) Rules, 1973.
