	29.10.2024	<p>In preferring the Criminal Revision under section 439 read with section 435 of the Code of Criminal Procedure there had been a delay of 91 days for which the petitioner filed an application under section 5 of the Limitation Act.</p> <p>Considering the facts and circumstances, the delay of 91 days in filing the revision is hereby condoned.</p> <p>Let records be called for and realization of fine be stayed.</p> <p>Let a rule be issued calling upon the opposite party to show cause as to why the judgment and order dated 29.05.2024 passed by the learned Additional Metropolitan Sessions Judge, 1st Court, Rajshahi in Criminal Appeal No. 399 of 2022 dismissing the appeal and thereby affirming the judgment and order of conviction and sentence dated 13.11.2022 passed by the learned Chief Metropolitan Magistrate, Rajshahi in G.R. No. 18 of 2019 arising out of Chandrima Police Station Case No. 18 dated 18.01.2019 convicting the convict petitioner under table 8(Ka) of section 36(1) of the Madak Drabbo Niyontron Ain, 2018 to suffer rigorous imprisonment 01(one) year and to pay a fine of Tk. 5,000/- (five thousands) in default to suffer simple imprisonment for a further period of 01 (one) month should not be set aside and/or pass such other or further order or orders as to this Court may seem fit and proper.</p>

Shahidul Islam, son of late Auyb Ali be enlarged on ad-interim bail for a period of 01 (one) year on furnishing bail bond to the satisfaction of the learned Chief Metropolitan Magistrate, Rajshahi.</p> <p>The rule is made returnable within 4 (four) weeks from date.</p> <p>The petitioner shall put in 2 (two) sets of requisites within 7 days, for service of notice of the rule upon the opposite party in normal course as well as by registered post with A/D as per HCD Rules.</p> <p>Office shall not issue any certified copy or other copy of this order to the petitioner unless requisites are put in vide HCD Rules, Chapter IV Rule 3(6).</p>
