	<u>27.11.2024</u>	<p>In preferring the Criminal Revision under section 439 read with section 435 of the Code of Criminal Procedure there had been a delay of 113 days for which the petitioner filed an application under section 5 of the Limitation Act.</p> <p>Considering the facts and circumstances, the delay of 113 days in filing the revision is hereby condoned.</p> <p>Let records be called for and realization of fine be stayed.</p> <p>Let a rule be issued calling upon the opposite parties to show cause as to why the judgment and order dated 04.06.2024 passed by the learned Additional Sessions Judge, 5th Court, Chattogram in Criminal Appeal No. 929 of 2018 dismissing the appeal and thereby affirming the judgment and order of conviction and sentence dated 05.11.2018 passed by the learned Senior Judicial Magistrate, Sandwip Chouki, Chattogram in C.R. Case No. 312 of 2017 (Sandwip) convicting the convict petitioner under section 4 of the Dowry Prohibition Act, 1980 and sentencing him to suffer rigorous imprisonment for 01 (one) year 06 (six) months and also to pay a fine of Tk. 5,000/- in default to suffer simple imprisonment for a period of 01(one) month more should not be set aside and/or pass such other or further order or orders as to this Court may seem fit and proper.</p>
