No. 773 of 2023</b> under sections <b>143/447/323/325/326/307/354 and 506(2)</b> of the Penal Code, now pending in the Court of Senior Judicial Magistrate, <b>Teknaf, Cox's Bazar</b> and/or passed such other or further order or orders as to this Court may seem fit and proper.</p>

		<p>Pending disposal of the Rule, let the accused-petitioner <b>Md. Alamgir, son of late Abdul Gafur</b> be enlarged on ad-interim bail for 01 (one) year from date on furnishing bail bond subject to the satisfaction of the learned <b>Senior Judicial Magistrate, Teknaf, Cox's Bazar.</b></p> <p>The Rule is made returnable within 04 (four) weeks from date.</p> <p>The petitioner shall put in 2(two) sets of requisites within 7 days, for service of notice of the Rule upon the opposite party in normal course as well as by registered post with A/D as per the provisions of the Supreme Court of Bangladesh (High Court Division) Rules, 1973. The office shall not issue any certified copy or other copy of this order to the petitioner unless requisites are put in as per the provisions of above Rules.</p> <p>The court below is at liberty to cancel the bail of the petitioner in accordance with law, if the privilege of bail is misused by him in any manner.</p> <p>The accused-petitioner is also directed to file affidavit of facts stating the latest position of the case if further extension of bail is needed.</p> <p style="text-align: right;"><i>Shajedul/ABO</i></p>
